## **Charging and Remission Policy**

The Governing Body of Dame Ellen Pinsent School is committed to providing quality education based on equality of opportunity, access and outcomes. In practice, this means the children have an entitlement to benefit from all educational activities and to:

- Participate fully in the school curriculum
- Contribute to all aspects of school life and
- To be a valued partner in the process of education

These objectives must be seen to inform educational activities, whether in or outside the school and therefore integral to the process of charging for school activities and to the remission which is available to parents and carers who are on a low income. We aim:

- To make school activities accessible to all students regardless of family income
- To encourage and promote external activities which support and give value to the curriculum.
- To provide a process which allows activities to take place at a minimum cost to parents, pupils and the school and
- To respond to the wide variations in family income while not adding additional unexpected burdens to the school budget.

The development of a range of activities forms part of the school's forward planning process and is linked to the annual budget cycle with a particular emphasis on the identification of specific resources to support such activities.

It includes a number of key factors:

- The value of certain activities in relation to age / need of pupils
- The cost of activity set against their educational value
- How the activity will be paid for
- The appropriate process for raising funding
- An assessment of whether the educational aims can be met in any other way
- An understanding of the various types of activities involved, for example, educational visits, music tuition, materials for practical work
- Reference to additional or hidden costs, for example, lunch money and pocket money.
- An assessment of local facilities.
- Education at Dame Ellen Pinsent School is provided free of charge for all lessons and activities organised wholly or mainly during normal school time in accordance with pupil entitlement under the Education Reform Order.

Although the school cannot charge for school activities, we may still invite parents and others to make voluntary contributions, the essential point being

that no pupil may be left out of an activity because his or her parents cannot or will not make a contribution of any kind.

#### **Activities Outside School Hours**

Parents can be charged for activities that happen outside school hours when these activities are not a necessary part of the National Curriculum or Religious Education.

#### Residential Activities

For a residential activity taking place largely during school time or essential to the education provided at the school, a charge will be made for the education / cost of travel, board and lodging. A subsidy is available for families in need (e.g. Pupil Premium/Charity).

## Charging in Kind

The cost of materials, ingredients and equipment is chargeable for the following subjects; DT, Science, Art / Craft. The Governing Body reserves the right to charge for ingredients and materials or require them to be provided if the parents have indicated in advance that they wish to own the finished product.

#### General

The Governing Body may from time to time amend the categories of activity for which a charge may be made. Nothing in this policy statement precludes the Governing Body from inviting parents to make a voluntary contribution towards the cost of additional activities which take place in school time. Parents may be advised that the continuance of an activity may depend upon voluntary contributions, but once it has been decided to run such an activity no qualifying child will be excluded on the grounds of voluntary contributions.

#### Remissions

To ensure that access to activities becomes a reality and that outcomes reflect intentions, Dame Ellen Pinsent School will implement the following Remissions Policy. The fundamental aim of this policy is to ensure that all pupils gain fully from everything that the school is able to offer them and is based on an understanding of the relationship between low income, entitlement and access. This policy takes into account the very real and persistent difficulties which people on low income have in meeting the costs of educational activities for their children.

#### **Implementation**

Planning, as part of the process of budget building is essential to developing a charging policy at Dame Ellen Pinsent School which recognises equality of access. We will endeavour therefore to produce a programme of activities based on a clear set of priorities identified by the school.

Such a process however, should not inhibit flexibility and the capacity of the school to take advantage of opportunities which arise during the course of the year. These will be implemented in a way which is consistent with the schools' overall policy.

## **Equal Opportunities**

We regard every member of school or visitor as of equal worth and importance, irrespective of his/her creed, culture, class, race, gender, (including gender reassignment), disability, sexual orientation, religion and belief, marital/civil partnership status or age.
